ORGANISATIONAL BOUNDARY

Our methodology takes into account the following GHGs: carbon dioxide (CO_2) , methane (CH_4) , Nitrous Oxide (N_2O) and hydrofluorocarbons (HFCs). CH_4 , N_2O , and HFCs were converted into CO_2 equivalents based on their global warming potential from the IPCC Fifth Assessment Report. CIMB Group's consolidation and reporting on GHG emissions is based on the 'control approach' i.e., we will account for 100% emissions only from our operations where we have direct operational control. We disclose Direct (Scope 1) GHG emissions and Indirect (Scope 2) GHG emissions for CIMB business operations in Malaysia, Indonesia, Singapore, Thailand and Cambodia. Other Indirect (Scope 3) GHG emissions are disclosed progressively, increasing from three to seven categories this year, which now includes Category 1, 5, 6, 7, 8, 9 and 13.

Note that, as part of our transition to comply with IFRS reporting requirements, we are now disclosing Scope 1 and 2 emissions for CIMB Group's subsidiary – Touch 'n Go (TNG) and TNG Digital (TNGD) for the first time separately in page 28 of the 2024 Sustainability Report. In 2024, emissions from these subsidiaries accounted for less than 0.6% of CIMB operational banking businesses' total emissions and are not included into CIMB's Total GHG Emissions below.
